1. Call to Order

Call to order at 9:10am. Quorum present.

2. Meeting Notes for October 7th, 2016 Meeting (*to be distributed*) Motion to approve minutes made by Rep. Fred Rice. Seconded by Sherry Godlewski. October minutes approved unanimously.

3. Update on Final Report

Nathalie gave a short update on the final report status and changes. Small changes were made to:

Population changes (found better source)

In section 4, Julie suggested to change term "redevelopment" to "reconstruction" Cliff asked about including population change in the county. Group decided not to since the report focuses on 17 municipalities.

Port statistics (found better source) Cliff likes the change to the port information. General agreement. Julie asked if the term Port Authority terminal operators included private companies. Renny explained that it does. Agreement to keep proposed changes.

Floodplain table changes. Fixed erroneous interpretation of the data. General agreement to keep changes. Cliff proposed that we should list the Newington representative as "vacant." General agreement.

Nathalie said this is the last day to make any changes. Nathalie will send version Tricia edits to Roger for reporters in a week or so.

Cliff suggested an edit to Our Economy. Change term 6.3 feet sea-level rise plus storm surge scenario; remove "daily tidal flooding." Cliff, Nathalie, and Kirsten will talk about it.

Nathalie noted that values have changed; Tides to Storms 7,000 parcels \$4.4 billion, includes Portsmouth now. C-RiSe 1600 parcels ~\$800,000.

4. Printing cost estimate(s) and status of funding NHCP will print 250 copies. Cost is a little over \$5,000.

Cam suggested, should we include a statement of how to reference the report. Add after acknowledgements piece or on inside cover. General agreement.

Something like: New Hampshire Coastal Risk and Hazards Commission. (2016). Title. URL.

Rep. Cushing suggested it should go on the general court website. Senator Watters will take care of that.

5. Preparing for Report release press conference: November 30, 11:00AM, LOB LobbyPress Release and embargoed report distribution

Roger suggested having a press conference format similar to March 2016. Sen. Watters and Rep. Rice will come up with key talking points. Rep. Rice and Sen. Watters will get back to Sen. Watters. Cliff will talk about the key points.

Roger will get together with Cliff, Sen. Watters, Rep. Rice, and Sherry on a conference call. Committee decided to talk about the key messages now.

Cam suggested lead with punch and not with the justification. Kirsten and Nathalie will make the two pager. Consider bringing the King Tide photos printed on foam board. New legislator orientation takes place November 30. Rep. Cushing suggested getting the press conference on the orientation agenda. RPC will make the poster and take care of easel.
