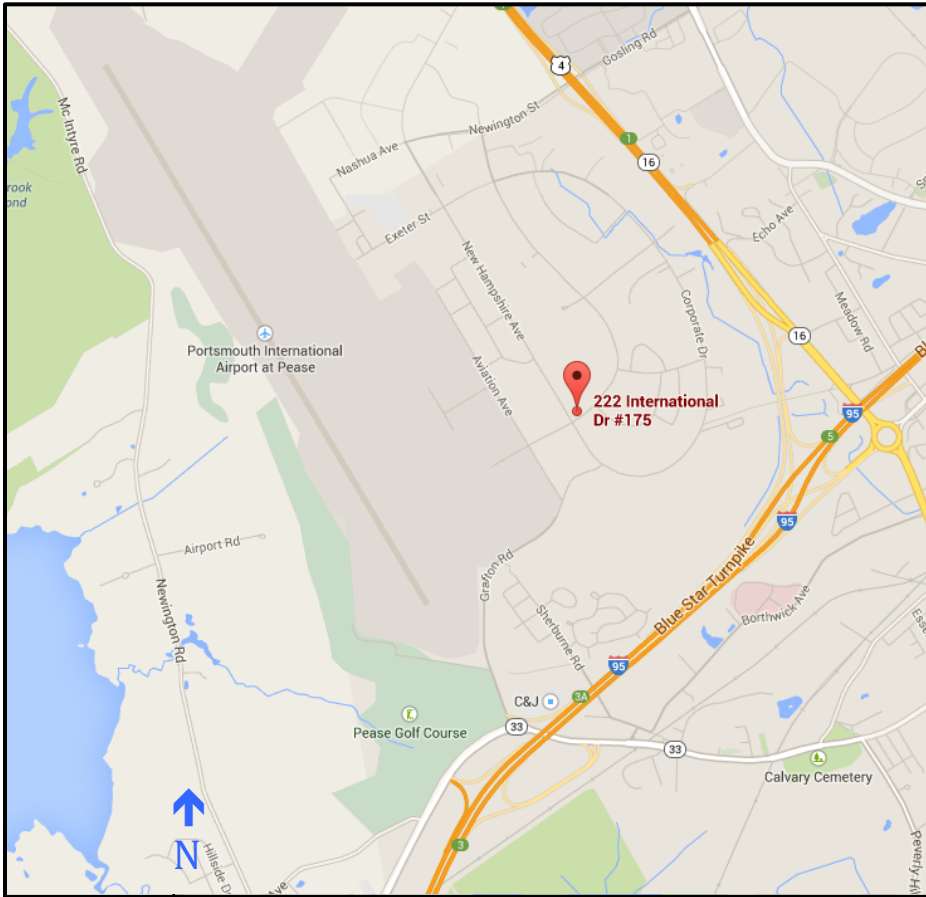

FROM I-95 AND NH33/GREENLAND ROAD:
Enter the Trade Port via Grafton Drive. Turn left at the "T" intersection with New Hampshire Ave. No. 222 International Drive is at the corner of New Hampshire and International Drive. The NHDES Office is on the New Hampshire Ave. side of the building.

FROM SPAULDING TURNPIKE/GOSLING RD.
Enter the Tradeport at the Main Entrance on Gosling Rd (Newington St.) and take first left onto International Drive. Proceed about 1.3 miles to intersection with New Hampshire Ave. No. 222 International Drive is on the right at the corner of New Hampshire and International Drive. The NHDES Office is on the New Hampshire Ave. side of the building.
